EXECUTIVE SPECIALIST RECRUITER SERVICES

1. Purpose

The Durban ICC requires the services of a specialist recruiter / firm which has substantial experiencing in recruiting personnel for executive level positions (once off service).

2. Mandatory Requirement

2.1 The service provider must have minimum 10 years' requisite experience directed at executive management recruitment positions, including a list of 'blue chip' companies for which positions have been recruited for.

- Please submit information to support the above.
- Failure to meet the mandatory requirement will result in the service provider being deemed non-responsive and not evaluated further.

3. Scope of works

- 3.1 The recruitment agency will have to work closely with the Durban ICC to develop an accurate and compelling brief for each executive role we seek to fill.
- 3.2 We will require a director-level executive recruiter who interviews the candidates and creates our short list.
- 3.3 We should receive a short list of candidates within 3 - 4 working days.
- 3.4 Each candidate must have already passed a rigorous vetting process which needs to be made transparent by the recruitment agency.
- 3.5 Every candidate must be screened and interviewed, references checked, and CVs validated.
- 3.6 The recruiter should have an existing database of executive management profiles


